



Cat Boarding Contract

This Contract is between Purrfurably Cats (hereinafter called the "Kennel") and the pet owner/representative whose name(s) appears below (hereinafter called the "Owner"). The term "cat" refers to all cats boarding with the same ownership.

Please read carefully and initial each item.

- ___1. Owner understands that the boarding fee is charged on a per day basis. The day of arrival is charged as a full day (regardless of check in time). For the day of check out there is no charge if the cat is picked up prior to 9:30am. Pick-up between 9:30am-12:00pm there is a half-day charge and after 2:00pm a full day is charged. If pick-up is needed between 12:00pm-2:00pm please notify kennel staff ahead of time so arrangements can be made.
- ___2. Owner understands that Purrfurably Cats is not a 24-hour facility. Kennels are not monitored between 5 pm and 8 am. Cats requiring overnight care, or medical monitoring or services need to be boarded at a 24-hour facility. Owner asserts that all known medical and behavioral history of cat has been disclosed to Kennel before boarding.
- ___3. Owner understands that Kennel staff is not a veterinarian or registered veterinary technician. Kennel does not board any cats with medical conditions other than those stable with basic medications. If hospital boarding is needed that is available at an additional cost.
- ___4. Owner understands that extra charges may be added to the bill at the discretion of management for special handling or treatment that is above and beyond routine care, i.e. an unexpected bath, etc. Special handling is defined as services beyond our standard boarding care due to behavioral problems, excessive accidents, health issues, or other unexpected care not anticipated at time of check in. Owner agrees to pay all such charges.
- ___5. Owner understands that if Kennel has to supply food, there will be an additional charge per day per cat. Owner also understands that a change in food may result in diarrhea.
- ___6. All cats entering Kennel must be clean and flea free. If upon inspection, this is not the case, a Capstar flea control pill will be given at the Owner's expense.
- ___7. Owner understands that very old cats may be sensitive to a change in environment and even though personal attention & care is given to all cats, this change in environment may be just enough to lead to stress induced disease or underlying medical condition to be presented.
- ___8. Owner represents that cat is healthy and has not been exposed to any known communicable disease within thirty-day period immediately prior to boarding. Owner agrees to disclose to Kennel all known medical conditions and/or behavior problems, which may affect cat's care prior to check in. Owner shall inform Kennel of any changes in cat's condition and behavior at or prior to check in for all subsequent boarding stays.

___9. Kennel specifically requires all pets to be vaccinated against Rabies and Distemper/Upper Respiratory disease. If the cat is not found to be up to date on vaccines at the time of check in vaccines will be given during stay at the expense to the Owner. This includes a veterinary exam charge.

___10. Owner releases Kennel from, and waives all claims and liability against Kennel for, damage to, or loss of, personal equipment or belongings provided by Owner for cat while the cat is boarded. Items not taken home at check out will be donated if not picked up within 60 days of check out date.

___11. Owner understands that Kennel reserves the right to refuse service due to cat's behavior or health, excessive cancellations, no shows, or late arrivals, non-payment, or violations of said contract.

___12. Owner understand that Kennel will do all it can to ensure that owner's cat will have a safe and enjoyable boarding experience. However if emergency medical treatment is required, after making reasonable attempts to first contact Owner, we will provide the treatment here at our office under the following the conditions that Owner has specified below:

A. ___ **Save my pet regardless of the cost** with any necessary treatment, medication, or surgical procedures.

B. ___ Use any and all reasonable and customary treatments, medications, or surgical procedures necessary to treat my cat, **not to exceed \$_____**

C. ___ **Owner does not want cat to be treated by a veterinarian under any circumstance, even in a life-threatening situation.**

Item D is **optional** and may be selected as an additional choice:

D. ___ At the discretion of the veterinarian in charge of my cat's care, if my pet is suffering and/or has lost all quality of life, I hereby authorize and request euthanasia for my cat. (Again, we would make every attempt to first contact Owner prior to any action).

By signing below, Owner states that he or she has read and agrees to all of the terms listed in this boarding contract. This contract will stay on file and be in effect for one year from the date signed, unless Owner requests to make a change.
