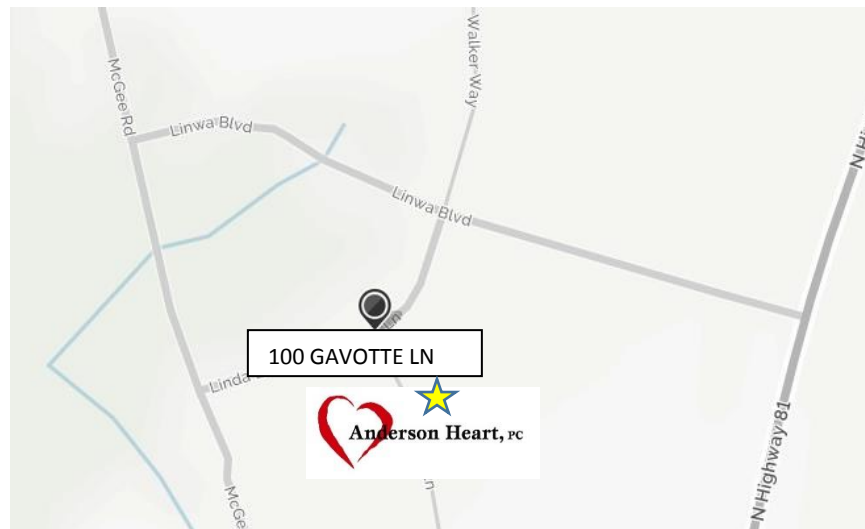

#### Payment & Insurance

Payment is expected when services are rendered unless the practice is a participating provider with your insurance carrier. If we participate with your insurance carrier we will file your claim and ask that you pay your portion of the balance on the date of service. If you have a co-payment amount on your card, then you will be asked to pay your co-payment at the time of service. We allow 45 days for the payment from the insurance carrier. If payment is not received within this time you will become responsible for the balance due.

If we do not participate with your insurance company we will file your claim, but you will be responsible for any out-of-network fees and co-insurance amounts at the time of your appointment. If you have secondary coverage, we will file the claim for you as a courtesy, but if you are covered by a plan that requires you to pay a co-payment, you will be expected to pay your co-payment amount and we will not file a secondary claim for you.

If you have any questions or concerns about your insurance, your statement or bill or your ability to make payments, please contact the office and ask to speak with our billing department.

## DIRECTIONS TO OUR LOCATION

### FROM I-85 N:

From I-85 N take Exit Ramp 27 to Hwy 81 N. Turn left off of the ramp onto Hwy 81 N until you pass Food Lion on the left at the 3<sup>rd</sup> traffic light. Pass under the traffic light and proceed south until you reach Linwa Blvd on the right. At the intersection of Linwa Blvd and Linda Ln you will turn Left onto Linda Lane then turn Left onto Gavotte Ln.

### FROM DOWNTOWN ANDERSON:

Follow E. Greenville St towards Hwy 81 N. Linwa Blvd will be on your Left after passing TL Hanna High School and North Pointe Elementary School.
